TEEN INFO:

Welcome to Camp Nightmare! You or your parent/guardian must register online to save your spot. Your parent/guardian will be contacted prior to the lock-in in order to make sure the information is valid.

Sign in no later than 8:15 p.m., because that is when the doors lock! Once admitted, you will not be allowed to leave until pick-up at 6:00 a.m. the next morning, unless your parent/guardian makes prior arrangements.

What to wear:

- Dress in your best camper outfit or spooky costume. Make sure your upper body and backside are fully covered.
- No masks.
- Just be comfortable!

What to bring:

- You are welcome to bring electronic devices, but you will be responsible for them! Library staff will not be responsible for lost devices.
- No real or pretend weapons, even though they may be part of a costume.

If you break any library rules or do not abide by staff instructions, you will be given one warning. If a second offense is committed, a parent/guardian will be contacted and asked to pick you up.

PARENT INFO:

A parent or legal guardian must register online to reserve a spot and sign a permission slip by the night of the lock-in.

Permission slips will be available to sign at the lock-in when you sign in your teen. These documents will also be available at the branches before the lock-in.

If your child is driving themselves, permission slips must be signed and submitted to any library by Thursday, June 6.

For the purpose of this event, “teen” is defined as being between the ages of **12 and 17 (at the time of lock-in)**. Eleven-year-olds who will attend 7th grade in the fall may also attend.
