## MINUTES

A special meeting of the St. Charles Parish Library Board of Control was held at 5:00pm, Tuesday, February 20, 2024 in the meeting room at the West Regional Library in Luling.

Mrs. DeLaune called the meeting to order and asked all to stand for a moment of silent prayer followed by the Pledge of Allegiance.

Mrs. DeLaune asked for approval of the minutes of the November 14, 2023 meeting. Mrs. Windmann moved that the minutes be approved as e-mailed. The motion was seconded by Mrs. Armstrong and passed unanimously.

The next item of new business was the Hahnville Branch Library Project – Selection of Architectural Firm. Two firms were selected to give a presentation to the Library Board of
